



## **Sewer Service Charge Rebate Assistance Program**

The Mt. View Sanitary District Sewer Service Charge Rebate Assistance Program provides a 20% discount in the form of a rebate check, issued after all property taxes for the applicable parcel have been paid. This application applies to one single-family residence.

To be eligible for the program, applicants must meet the following requirements:

1. Own and occupy a residence located within the District's boundaries in Contra Costa County.
2. Be enrolled in the PG&E CARE Program.

The application period is June 1<sup>st</sup> to November 30<sup>th</sup>. Applications not submitted within the application period will be denied. A new application must be submitted each year to continue receiving the rebate.
